


Remove Bin, Carts, and Contents from the bin (lower drain pan)

Peel PVC film from the front panel, shovel door.

Remove bin top (For poly tops remove H-Frame) and set aside.

Save all packaging until machine is installed and running properly.





Position transport system into desired location carefully to not damage legs or any functioning parts on the front, back, side or under the bin.


Remove lag bolts connecting flanged feet to pallet.

Remove Bin from Pallet.

Level the bin if needed adjust the feet by rotating the flange or bullet to level the unit.

Attach drain hoses to upper and lower pans and secure using pipe clamps.

Return Bin top (for poly topensure H-frame is in place)



CLEANING AND SANITATION INSTRUCTIONS

NOTE

CHLORINE BASED CLEANERS MAY CAUSE CORROSION OF THE STAINLESS STEEL

BEFORE USING ICE BIN

Clean and sanitize all surfaces using a quaternary cleaner/sanitizer

STAINLESS STEEL & POLY LINER CLEANING PROTOCOL

• Bi-Monthly Cleaning

- With a clean dry cloth, wipe down internal ice bin ceiling, doors, snouts, baffles, and windows
- Quarterly Cleaning (for heavy use bins conduct this cleaning monthly)
 - 1. Empty bin completely
 - 2. Wash with mild soap and water, including augers, agitators, snouts, and baffles, and rinse thoroughly.
 - 3. Then use quaternary cleaner/sanitizer* on all surfaces including augers, agitators, snouts, and baffles, and let dry per cleaning solution instructions.
 - *Recommend EcoLab No Rinse Food Contact Cleaner Sanitizer.

TROUBLE SHOOTING

Heavy deposit

- 1. Empty bin completely
- 2. Wash with mild soap and water, including augers, agitators, snouts, and baffles. Use vigorous agitation on deposit areas. Rinse thoroughly.
- 3. Then prepare a diluted nitric acid solution (5-10% HN03).

 Apply a light layer of the solution to the liner and allow to stand for 30 minutes.

 Rinse the liner with clean water.

RECOMMENDATION

To minimize bin contamination, use a water softening system that reduces ferrous minerals and particulates

Shovel Door Replacement Instructions

Tools & Parts needed:


Vice grips/channel locks Pliers

Riveter/rivet gun Bushings (2)

Replacement door Rivets (2)

Dry fit door to determine fit, there is usually a slight gap between door and hinges. Using pliers gently bend tabs (top and bottom) on unit to shorten the distance, careful to not over bend which may cause the hinge to break (Figure 1)





Repeat this process on the door tabs (Figure 2)

Line up bins tabs and door tabs. Take vice grips/channel locks and use to hold bottom of door in place. Then place bushing into the hole. With bushing in position carefully set rivet into place. (Figure 3)



Shovel Door Replacement Instructions

Using riveter/rivet gun squeeze tight applying enough pressure to keep rivet in place. (Figure 4)





For bottom side remove vice grips/channel locks to access hinge. Repeat step with bushing, rivet and riveter/rivet gun. (Figure 5)

Once secure release and test door.

Shovel Door Hood Replacement Instructions

NOTE

Ice level should be below bottom of shovel door before removing the hood

Removal Instructions

- 1. Disconnect power supply **For DISP Models ONLY**
- 2. Open shovel door
- 3. Locate thumb screws on the interior side of the shovel door (both left and right side about 2" up from the bottom of the door)
- 4. Loosen one screw (about ½"); do not remove the screw. Support the hood with one hand and loosen and remove the second thumb screw.
- 5. Slide the hood off the first screw. Lower the hood and turn to remove it out the shovel door opening.





Installation Instructions

- 1. Remove protective plastic coating from the plexiglass window
- 2. Turn the hood sideways the slide through shovel door opening.
- 3. Slide the hood under the lip on the interior upper side of the door. The slide onto the thumb screw that was left in place on the interior side of the door.
- 4. Supporting the hood with one hand put in the second thumb screw and tighten well. Now tighten the first screw.
- 5. Check to ensure plexiglass window moves freely up and down.

Manufacturer's Warranty

Kloppenberg warrants that it will repair or replace at its own expense any commercial ice bin of its manufacture bearing the name Kloppenberg due to a factory defect in material and/or workmanship occurring within the first twelve (12) months from the date of installation or eighteen (18) months from date of shipment providing, the ice bin has been installed, and maintained in accordance with the procedures set forth in the product manual provided with each ice bin.

This warranty does not include parts or labor coverage for a factory component failure, or other damage resulting from:

- Failure to clean and maintain as set forth in the product manual
- Adverse operating conditions
- Drain line malfunctions
- Water content irregularities for any reason
